Key provisions in the Charities Act 2022

- Permanent endowment
 - More borrowing flexibility
- Changing a charity's purpose
 - ➤ The Charity Commission will assess:
 - ➤ The original purposes of the charity;
 - The desirability of the proposed changed purposes to be similar to the original one; and
 - The need for the purposes to be suitable and effective in the light of current social and economic circumstances.





Key provisions in the Charities Act 2022 (Autumn 2023)

- Appointing new trustees
 - > Ratify invalid appointments
- Disposal of charity land
 - Wider category of 'designated advisors'
 - Additional considerations for charity trustees
- Charity incorporations or mergers
 - Legacy protection

Unlocks £880 million of dormant assets


- DCMS consultation

 - (Closed 9 October 2022 feedback still being analysed)







Blacker v Charity Commission for England and Wales [2022]

• Refusal to grant a disqualification waiver

Frank Wingett Cancer Relief Fund [2022]

• Restitution from trustee – mis-applied funds


